CONDITIONS

The pool will be rented on a "first-come, first-served" basis by contacting the Drummond Hill Pool Inc. Board of Directors. No more than 2 parties will be scheduled at the same time during pool hours. The pool will only be rented to a current member of the pool who is hereafter referred to as the "sponsor." Rental Form, Liability Form, and all Fees are due at time of reservation to hold date.

LIABILITY WAIVER

The attached Liability Waiver must be signed and returned to the Drummond Hill Pool, Inc. at the time of reservation. The event cannot take place without the signed liability waiver. The sponsoring member is responsible to ensure that all guests understand that all rules and regulations regarding normal pool operations apply to rentals. In the event of disregard of the rules or regulations, excessive noise, or uncontrollable behavior by any person during a rental, the lifeguards, any officer, or the rental Chair may immediately terminate the rental, in which case there shall be no refund of the rental fee. In addition, the sponsoring member's continued membership may be terminated by the Board of Directors, consistent with the By-Laws.

HOURS

- Adult events (majority present over 21) – 8:00 p.m. to 11:00 p.m.
- Teen events – 8:00 p.m. to 10:00 p.m (3 hours permissible if party starts at 7:00 p.m. (-10:00 p.m.), but first hour will be shared with members during pool hours.
- During Pool Hours – Two (2) parties of three (3) hour duration may be held concurrently during normal pool hours. If the party continues after normal hours the after hour guard fees will apply in addition to any guard fees incurred for the party during normal pool hours.

OTHER INFORMATION

Kitchen is available for your use during party hours. **DO NOT** use the Swim Team Refrigerator. There is a second refrigerator for members' use.

Charcoal grills are available for your use during your party. These are charcoal grills, not gas grills. You will need to provide your own grilling supplies.

Party set-up time is 30 minutes prior to your party time.

Release of Liability / Assumption of Risk (Read Before Signing)

In consideration of being allowed to use, or rent the facilities of Drummond Hill Pool, Inc., the undersigned acknowledges and agrees with all of the following:

1. I am aware the risk of injury from activities and events involved in using the pool, grounds and facilities is significant including the potential for permanent paralysis and death and while particular rules, equipment and personal discipline may reduce the risk, the risk of serious injury does exist.
2. I knowingly and freely assume all such risks, both known and unknown, even if arising from the negligence of the employees or officers of the Drummond Hill Pool, Inc., and assume full responsibility during my participation and the participation of every person attending my event.
3. I willingly comply with Drummond Hill Pool procedures for rentals and with all applicable Rules and Regulations. In the event I observe or learn of any dangerous or hazardous activity or condition, I will immediately take appropriate action to cause the activity to cease and immediately will bring the activity to the attention of the lifeguards, any officer of the Pool and rental Chairperson who may be present. In the event I observe any dangerous or hazardous condition on the pool grounds, I will immediately take the appropriate action to ensure that my guests stay away from the condition, and will immediately bring the condition to the attention of the lifeguards, any officer of the Pool and rental Chairperson who may be present.
4. I, for myself and on behalf of my heirs, assignees, personal representatives and next of kin, hereby release and hold harmless Drummond Hill Pool, Inc., its officers, directors, agents, and employees (collectively "DHP"), from any and all loss or damage arising from the rental event, including but not limited to injury to person or property, disability and death, whether such loss or damage arises from the negligence of DHP or otherwise.

I HAVE READ THIS RELEASE OF LIABILITY AND ASSUMPTION OF RISK AGREEMENT, FULLY UNDERSTAND ITS TERMS, UNDERSTAND THAT I HAVE RELINQUISHED SUBSTANTIAL RIGHTS BY SIGNING IT, AND SIGN IT FREELY AND VOLUNTARILY WITHOUT ANY INDUCEMENT.
